Destiny received an email from the Oregon California Auto Trails Program and they have lowered their rate to \$750.00 After council discussion it was decided not to advertise with this program.

Website Report

Unique Visits are down a bit from last year. Google visits were down. Many were searching for Soda Springs Fishing Derby, Snowmobiling and Fishing. Birgitta's Facebook Ads for Hot Springs were very successful! 1427 Click from Facebook Ads for Hot Springs. ArcGIS Snowmobile Map viewed 215 times in January. Cross Country Map was viewed 23 times in January. "Send in Blue" is the new company for newsletter.

Merlin Films-Matt Linton Video Production Services

Merlin Films-Matt Linton (Owner) is a video production company. They produce videos on travel destination marketing. Destiny forwarded a video package from Merlin Films to council to view before meeting. Ann Yearsley put the video up on a screen at the meeting.

Video options:

- We could target top 10 regional spots-locations on a video to let our customers know what our region has to offer.
- Twitter campaign to have input into the video campaign.
- QR Codes in video to designate each location. Customers can scan a QR code on their phones with information of each location.
- People remember 85% of information in a video compared to 10% in print material.
- YouTube and web based videos. merlinfilmssusp.com
- The Millard County Video is a six minute video and cost \$8,000-\$10,000.
- The cost is \$800.00 per day and for multiple days the price decreases per day. What direction would HCT want to go with a video project then he could give a more specific price.
- Matt recommended starting with 3 minute videos possibly 2-3 minutes videos.

The council will discuss options for video and cost then contact Matt with decision.
