#### Website Report

Webmaster Ann Yearsley reported on the website statistics. The unique visits are up 49% from last year. Google visits were up 39%. Direct visit was 146%, probably from Ads. 1000 more visits from Idaho that Utah. Utah usually beat out Idaho for visits. The Newsletter has an average 4054 opens. Visits in 2019 compared to 2021 before Covid we are down 7% but we are working our way back up now that events are coming back. The newsletter was sent to 74,689 recipients and was opened 4,054. Council can send new subjects to Ann to use in newsletters.

# Other Business

- 1. SE ID Touring Adventures Guide-4-page pamphlet that includes our region in the West Yellowstone Loop. The pamphlet needs to be reprinted due to low quantity. Birgitta will update-revise the information in the pamphlet then email to council for review and input. This pamphlet is distributed at ABA (American Bus Association) and RMI (Rocky Mountain International) conferences to Tour Bus Operators-Companies.
- 2. Tami Leonhardt-State Parks campground on the east side of Bear Lake has done improvements such as new parking lot with approximately 200 parking spots. State Park charges @ \$15.00 per vehicle. This campground is located on the Idaho and Utah border east side of Bear Lake.

The Bear Lake Hot Springs Campground is not opening the campground, but the hot springs pools are open to public. Epic Recreation Company owns the Hot Springs and campground.
